The Master of Health Administration builds a solid foundation emphasizing managerial, analytical and public policy skills for those entering the health field.

The MHA curriculum provides students with both breadth and depth. Upon graduation, students will have core competence in management and operations, health economics and policy analysis, healthcare finance, health information technology, and quality of care. The USC MHA program aims to prepare students for management positions in hospitals, managed care systems, physician groups, ambulatory care systems, consulting groups, as well as government agencies.

PPD 506, 516, and PPD 545: If a student has taken an equivalent, upper division course in microeconomics (for PPD 506), financial accounting (for PPD 516), and/or organizational behavior (for PPD 545) they may substitute those courses with elective units instead. For example, if a student has taken PPD 318, a financial accounting course, they may take 4 units of electives instead of PPD 516.

PPD 509, PPD 510a, PPD 516, and PPD 545: For Price's undergraduate Public Policy students, they may take PPD 509 towards their undergraduate degree requirement for PPD 413, PPD 510a for PPD 407, PPD 516 for PPD 318, and/or PPD 545 for PPD 320, up to the minimum required units of the MHA program (32 units or more).
